Cybercrime = \$10.5 Trillion by 2025

Case: E*MO (UK, 2020)

- ✓ Hack → \$10M+ lost
- Withdrawals suspended
- Investors pulled funds instantly

Encryption and Authentication

The First Line of Defense

Encryption

Keeps data unreadable to intruders

Two-Factor Authentication (2FA)

Stronger account protection

Biometric Verification

Adds certainty and convenience





Compliance = Credibility

AML KYC Global Standards

Case: Ro*in*ood Crypto (2022)

- Fined \$30M for weak AML & cybersecurity controls
- ✔ Financial damage, but trust loss was greater

Monitored Risk With Security = Investor Protection

Survive Volatility. Stay Protected.

Two types of risk

Market Risk

Volatility, price swings, uncertainty

Platform Risk

Weak systems, poor safeguards, outdated processes

Risk Protection With Landmark Markets

- ✓ Fined £108M for AML failures
- Massive reputational damage

Constant Monitoring. Proactive Defense.

Cybersecurity must run 24/7
— not just after a problem

Case: O*X

Fined ~\$505M for violating U.S. anti-money laundering laws.

Global Standards, Local Protection


Consistency Across Markets


